Charges from 1st April 2010

Agreement (Alternative) and General Conditions of Contract for:

- **The Provision and Maintenance of New/Replacement Metering Equipment.**
- **The Provision and Maintenance of Legacy Metering Equipment.**

In accordance with the terms set out in the above Agreements, I attach schedules showing National Grid's revised metering charges that will become effective from 1st April 2010. These schedules include tables from the Agreements that have been reproduced and updated to include the annual adjustment of prices in accordance with RPI as set out in the Agreements.

In general, the revised rental charges effective from 1st April 2010 incorporate a pricing decrease of 1% in respect of inflation (RPI). As a result of this pricing reduction the rental charges for credit meters are £12.61 per annum for a legacy 1 meter and £13.15 per annum for a replacement meter. The rental charge for a prepayment meter (legacy 1) reduces to £34.02 per annum.
